Notice is hereby given that the City Council will hold a Public Hearing on Tuesday, December 16, 2008, in City Council Chambers, 200 Common Street, Lawrence, MA at 7:00 p.m. The purpose of said hearing is to gather testimony, information, and public input concerning the proposed amendment to the Revised Ordinances of the City by adding a new section to the Lawrence Municipal Code, **Section 10.36.290 of the Municipal Code** (Two Hour Parking-Six a.m. to Seven p.m.), as follows:

Essex Street, north side, from a point twenty (20) feet easterly of the intersection of Hampshire Street to a point one hundred fifty (150) feet easterly of the intersection of Hampshire Street;

Essex Street, north side, from a point twenty (20) feet westerly of the intersection of Hampshire Street to a point one hundred fifty (150) feet westerly of the intersection of Hampshire Street;

Essex Street, south side, from a point twenty (20) feet easterly of the intersection of Hampshire Street to a point one hundred fifty (150) feet easterly of the intersection of Hampshire Street;

Essex Street, south side, from a point twenty (20) feet westerly of the intersection of Hampshire Street to a point one hundred fifty (150) feet westerly of the intersection of Hampshire Street;

and further, by **DELETING** the existing sections of the Lawrence Municipal Code, **Section 10.36.240 of the Municipal Code** (One Hour Parking-Six a.m. to Seven p.m.), as follows:

Essex Street, north side, from a point three hundred seventy (370) feet east of Franklin Street to a point thirty (30) feet west of Hampshire Street;

Essex Street, north side, from a point forty (40) feet east of Hampshire Street to a point one hundred fifty five (155) feet;

Essex Street, south side, from a point forty (40) feet east of Franklin Street to a point forty (40) feet west of Hampshire Street;

Essex Street, south side, from a point thirty five (35) feet east of Hampshire Street to a point thirty five (35) feet west of Amesbury Street;

And inserting in their place and stead

Essex Street, north side, from a point three hundred seventy (370) feet east of Franklin Street to a point one hundred fifty (150) feet west of Hampshire Street;

Essex Street, south side, from a point forty (40) feet east of Franklin Street to a point one hundred (150) feet west of Hampshire Street;

Essex Street, south side, from a point thirty one hundred fifty (150) feet east of Hampshire Street to a point thirty five (35) feet west of Amesbury Street;
